# The Journal of Illiberalism Studies

## **SUBMISSION GUIDELINES**

#### **Copyright and Licensing Terms**

Authors who publish in *JIS* agree to the following terms:

- 1. Authors retain copyright and grant the journal right of first publication with the work simultaneously licensed under a <u>Creative Commons Attribution License (CC-BY 4.0)</u>. This means that all content is freely available without charge to readers. Users are allowed to read, download, copy, distribute, print, search, or link to the full texts of the articles, or use them for any other lawful purpose, without asking prior permission from the publisher or the author. This is in accordance with the BOAI definition of open access.
- 2. Authors are able to enter into separate, additional contractual arrangements for the nonexclusive distribution of the journal's published version of the work (for example, to post it to an institutional repository or publish it in a book), with an acknowledgement of its initial publication in this journal.
- 3. Authors grant the publisher the right to deposit this work in an electronic archive or institutional repository system for long-term preservation at some future date.

## **Types of Publications Accepted**

JIS accepts:

## a) Research Articles

Articles should be between 6,000 and 10,000 words, including footnotes.

## b) Book Reviews and Discussions

Book reviews should be between 1,000 and 2,000 words.

A book discussion means at least 3 reviews of the same book, with an answer by the author.

#### c) Symposium

A symposium means at least 3 short articles that can be exploratory, accompanied by an introduction.

## d) Special Issues

A special issue means at least 3 research articles linked thematically, accompanied by an introduction.

## **Submission**

Each submission should be composed of:

1. A title page comprising:

- Article's title
- Full name, institutional address, and email of the author(s)
- Abstract (between 100 and 200 words)
- 5 keywords
- Number of signs, graphs, and tables
- Statement on Conflict of Interest
- Funding
- 2. The article text in a Word document
  - 1.0 line and paragraph spacing, Georgia, font size 10
- 3. Additional file with any graphs, tables, or visuals

#### **Double-Blind Peer Review**

The Journal uses a double-blind peer-review system, which means that manuscript authors do not know who the reviewers are, and that reviewers do not know the names of the authors. Files (manuscript, figures, tables, etc.) should not contain any information concerning author names, institutions, etc. The names of these files and the document properties should also be anonymized. The title page will not be made accessible to the referees.

#### **Proofs**

Upon acceptance, a PDF of the article proofs will be sent to authors by email to check carefully for factual and typographic errors. Authors are responsible for checking these proofs and are strongly urged to make use of the Comment & Markup toolbar to note their corrections directly on the proofs. At this stage in the production process only minor corrections are allowed. Alterations to the original manuscript at this stage will result in considerable delay in publication and, therefore, are not accepted.

#### Quotations

Quotations of more than 4 lines, which will be set as indented text in smaller type and line spacing, should not be preceded and followed by quotation marks, and should be double-spaced. Please adhere to American punctuation style, which uses double quotation marks [""] for the first level of quotation and single quotation marks ['"] for quotations within quotations. Sentence-final punctuation is to be placed *inside* the quotation marks, "like this." Authors are asked to use "smart"/ "directional"/ "curly" quotation marks [""] and not "straight" quotation marks ["].

#### **Figures**

Illustrations and photos should be submitted in TIFF or PNG format, scaled at 100%, with a resolution of at least 300 dpi (600 dpi is preferred). Number the files and clearly mark the spot where the photo should be inserted: ("insert ill. 2"). Provide the figure captions at the very end of the article.

## **Style Conventions**

The Journal uses American spellings (-*ize*, not –*ise*; *center*, not *centre*; etc.).

All non-English words, other than proper nouns, should be set in italic script, and along with all non-English names, they should be spelled with accents and diacritical marks included.

All numerical values of 10 or greater should be expressed as numerals rather than written out as words.

Please use symbols for the expressions %, \$,  $\in$ , and £, rather than their spelled-out wording equivalents.

An ellipsis ( ... ) within continuous text is usually indicated by three points. A fourth should be added at the end if the ellipsis finishes a sentence.

Abbreviations should be given in full at first mention, followed by the abbreviation in parentheses.

Please give the names of all organizations, political parties, etc., in the original language at first mention.

## Referencing

*JIS* follows the Chicago/Turabian system for formatting and citations. For more details and many more examples, see <u>chapter 14</u> of the *Chicago Manual of Style*.

Please ensure that the references in your submission are in notes and bibliography style (see chapter 14 of the *Chicago Manual of Style*), rather than in author-date / notes-and-bibliogrpahy style (cf. chapter 15). Please also provide digital object identifiers (DOIs) to references, if available, with a full URL.

Some other items to pay close attention to:

- Article titles in footnote references should be capitalized headline-style, and followed by a comma, not a period: "Illiberalism: A Conceptual Definition,"
- The abbreviation for "number" should be lowercased: no. 2
- There should be a month given before an article's year of publication whenever possible: (June 2022). Whenever available, the month and year of official print publication should be preferred over its initial electronic publication date.
- Numbers for page ranges are separated by an en-dash (-), rather than a hyphen (-).

## **Repository Policy**

Authors publishing in *JIS* may deposit the following versions of their paper in an institutional or other repository of their choice:

Submitted (Pre-Print) Version

We recommend including an acknowledgement of acceptance for publication and, following final publication, authors may wish to include the following notice on the first page:

"This is the pre-peer-reviewed version of the following article: [FULL CITATION], which has been published in final form at [link to final article using the DOI]."

#### Accepted (Peer-Reviewed) Version

The accepted version of an article is the version that incorporates all amendments made during the peer review process, but prior to the final published version (the version of record), which includes: copy and stylistic edits, online and print formatting, citation and other linking, deposit in abstracting and indexing services, and the addition of bibliographic and other material.

The version posted must include the following notice on the first page:

"This is the peer-reviewed version of the following article: [FULL CITATION], which has been published in final form at [link to final article using the DOI]. This article may be used for noncommercial purposes in accordance with Wiley Terms and Conditions for Use of Self-Archived Versions."

#### Published (Version of Record) Version

The version of record includes: copy and stylistic edits, online and print formatting, citation and other linking, deposit in abstracting and indexing services, and the addition of bibliographic and other material. The version of record may be shared only after the article has been published in *JIS*.

When published elsewhere, the source (*JIS*) must be acknowledged and a link to the Journal's homepage or the article's DOI must be set.

## **Fees for Services**

*The Journal of Illiberalism Studies (JIS*) does **NOT** charge submission fees, article processing fees, or any other type of charge for publication or submission.
